POLICY STATEMENT - G8

Violation of Greens Fee Rules

- 1.0 General:** A fee has been established for the privilege of playing a Recreation Centers of Sun City West, Inc. golf course.
- 2.0 Authority:** Section 4B.2a of the Bylaws, provides that the Governing Board is empowered to establish and publish policies, rules and regulations. Section 4B.2e further provides that the Governing Board may establish penalties, including but not limited to fines, probation or suspension of membership or membership privileges for the infraction of polices, rules or regulation. The General Manager, or his designees, shall have authority to enforce the provisions of this policy.
- 3.0 Purpose:** The purpose of this policy is to establish the penalties to be assessed for failing to pay the established green fee prior to initiating play.
- 4.0 Policy:** Any owner member, resident or nonresident playing golf on any Recreation Centers of Sun City West, Inc. golf course shall first pay the appropriate greens fee.
- 5.0 Penalties:** Upon demand of course manager, starter, or marshal, the violator shall immediately pay the applicable daily fee.
- 5.1 Owner Member or Resident:**
- 5.1.1 Within 24 hours following the first violation, the owner member or resident shall pay, at the course at which the violation occurred, the required greens fee plus a penalty fee of \$25.00. In the event that both fees are not received within the stipulated time frame, the owner member's or resident's golf privilege shall immediately be suspended until such time as the fees are paid in full.
- 5.1.2 For each subsequent violation, the owner member or resident shall pay a penalty fee of \$100, in addition to the applicable greens fee. Such payment shall be subject to the identical time frame, conditions and penalties for nonpayment, as enumerated in the preceding paragraph.
- 5.1.3 If, in the course of informing the owner member or resident of their violation, the owner member or resident refuses to produce an Owner Member or Resident card and/or becomes abusive he/she shall be requested to leave the course immediately. Refusal to comply with either request will result in all golf privileges being suspended by the General Manager pending a hearing before the Governing Board.

5.2 Non-Resident:

- 5.2.1 Any non-resident found in violation of this policy shall be asked to immediately leave the course and their privilege to play a Recreation Centers of Sun City West golf course shall be suspended for a period of six months for the first violation and one year for each subsequent violation. Reinstatement shall not occur until all applicable green fees have been paid.
- 5.2.2 In the event that the non-resident violator is a minor (under the age of 18) and in the accompany of an Owner Member or Resident at the time of the violation, play may continue and the Owner Member or Resident shall be assessed the appropriate greens fee and penalty fee outlined in 5.1 above, as if the Owner Member or Resident had personally committed the violation.
